PSS welcomes the Australian Pharmacy Council

The Australian Pharmacy Council (APC) has become a member of the Pharmacists' Support Service (PSS) subsequent to a change in the PSS constitution. This adds the APC to the other eight pharmacy bodies who are already members of PSS. Associate Professor Faye McMillan, a Wiradjuri yinaa (woman) from Trangie NSW, will represent APC on the PSS Board. Faye, an APC Board director, works at Charles Sturt University and holds a Doctor of Health Science, a Master of Indigenous Health Studies, Bachelor of Pharmacy and is Australia's first registered Aboriginal pharmacist. In addition Faye has a particular interest in mental health and is currently completing a Diploma in Counselling.

John Coppock, PSS President commented "We are delighted to welcome APC involvement in PSS. APC has a critical role accrediting Australian pharmacy education programs and assessing competency of pharmacists prior to registration. These foundational activities undertaken by APC are essential in setting the scene for the wellbeing of pharmacists throughout their career. We particularly welcome Faye as she will bring a new perspective to PSS with her background in indigenous health and her experience in education." John also noted that PSS is owned by the pharmacy profession, through these organisations, who have all invested in PSS rather than replicating services to support the health and well-being of pharmacists.
